Rubric Evaluation Guidelines:

- 1. In order to move forward with consideration each proposal must have a minimum average score of a 14.
- 2. All seven dimensions must have a minimum score of a 1 from all scorers.
- 3. The average score for each dimension must be a minimum of 1.5.

FSW Faculty-led Rubric Dimensions

- 1. International Travel How much international travel experience does the individual have?
- 2. College Mission— How well does the individual explain how the course meets the mission statement of the college?
- **3. Destination Experience** How knowledgeable is the individual with the destination they are proposing to teach students in?
- **4. Outcomes** How well have enhanced learning outcomes been explained using the location as leverage?
- **5. Program Itinerary Feasibility** How well does the individual explain the program components and excursions/activities related to the destination?
- **6. Program Concept & Marketing Appeal** How well is the overall concept explained including innovative opportunities to learn abroad that has the possibility for student appeal?
- 7. Budget Does the individual explain cost and provide budget information?
